I am pleased to share with you the July 2023 Newsletter Special Issue of the NATO Security Force Assistance Centre of Excellence (NATO SFA COE). The Centre is a multinational joint entity sponsored by Albania and Slovenia with Italy as the Framework Nation, and Austria as Contributing Participant, accredited by NATO in 2018. As the Alliance's key resource on Security Force Assistance, it plays a proactive role in advancing insights by academics and practitioners.

To this end, the Centre has strengthened cooperation with academic institutions and international organizations. For instance, the NATO SFA COE has signed cooperation agreements with the University of Ljubljana, the Military Academy of the Albanian Armed Forces (AFA), LUMSA University, the University of Verona and Luiss University in Italy and recently with York University's Glendon School of Public and International Affairs in Toronto, Canada. The NATO SFA COE was proud to take part in the Luiss Guido Carli's Career Day for Social Impact, offering an opportunity for students to become familiar with the Centre's work.

I am also proud to introduce the third editorial project of the NATO SFA COE: Stabilization and Reconstruction in a Post-Conflict Environment. This project builds on two recent editorial projects: Promoting the Rule of Law and Good Governance: SFA Implications in International Initiatives and Insights on Strategic Advising for Security Force Assistance. It explores a range of interdisciplinary issues that arise in post-conflict environments, with the aim of providing SFA advisors and NATO missions with practical tools.

The event was fundamental to meet the potential candidates for the periodic internship offered by the Centre, where particular importance was placed on the students' research, multidisciplinary approaches, different perspectives and interesting backgrounds of the interviewees.

The cooperation aims at an ever-closer relation between academia and the military institutions towards the common goal of promoting security and international cooperation.

Speaker Spotlight:Pancrazio Musilli

How important is it for your University to be able to offer to its students this internship with the Centre?

Our University offers a specific course of study in International Relations with a Major in Security. In the latter course, we try to give students the opportunity to test themselves by seeking out and offering these internships. The Security Studies course requires a high level of experience and as a result, when students do internships with the NATO SFA COE or the security world in general, they are given the opportunity to deepen their knowledge and put into practice what they have learnt at university. The internship with the Centre is a source of prestige for Luiss, to be able to offer a complete course of practical experience for the students, to bring them into direct contact with experts of the sector and to make them delve into current geopolitical themes.

Are civil-military collaborations important?

An enhanced collaboration between military and civil entities is an added value to the nation's system and method of addressing security challenges in our current complex reality. Today's world presents challenges that require the comprehensive approach of both civil and military expertise. Threats to security are more efficiently addressed when a cooperation between the two approaches is in place. Coordination of resources allows for optimization and avoids duplication of efforts achieving a mutually beneficial response when governmental organizations are involved. Moreover, the military forces have to comply to promote Security and Stability, in line with Cross-Cutting Topics (CCTs). The latter matters can be better understood and addressed, in collaboration with civilian actors. Finally, in distressed areas, a collaboration of the two entities can allow understanding of the root causes of conflict and facilitate promotion of reconciliation efforts through diplomatic and negotiating actions. Eventually, cooperation enables sustainable peace and security, and helps to avoid the recurrence of violence.

What is the University's selection process to access this internship?

The call for applications is published on our Career Center's platform and is open to all our students meeting the essential requirements. To apply it is necessary to be enrolled in an International Relations, Law or related topics course, to have a C1 level in English, a grade average of at least 28/30 and a passion for the Security Sector. Students are also asked to send a CV and a cover letter. The shortlisting candidates will be interviewed by the Centre's personnel, through which a successful candidate is selected.

Speaker Spotlight: Susan Pond

What are the benefits of the recent Letter of Cooperation concluded between the Glendon School of Public and International Affairs in Toronto and the NATO SFA COE in Rome?

Universities are about the exchange of ideas and enhancing decision making skills. It is only natural that we would seek to develop a partnership with an institution that shares our commitment to excellence. The Letter of Cooperation is open ended but starts with the creation of Internships. Glendon students completing an internship at the NATO SFA COE have a unique opportunity to work with a multinational staff engaged in peace, security and development. We are very pleased to be the first North American university to have concluded such an arrangement.

You had a long career with NATO working in Norfolk, Kyiv and Brussels. What do you see as some key accomplishments?

My NATO career coincided with the collapse of the Berlin Wall. These were exciting and uncertain times. I was lucky to be part of the first contact teams "extending the hand of friendship" to nations of the former Warsaw Pact and former Soviet Union. I was also part of the first "Partnership for Peace" office developing and implementing practical activities with former adversaries. From the outset my interests were associated with good governance and building capacity in the defence and security sector. These efforts led to NATO Heads of State and Government at the Warsaw Summit agreeing the Building Integrity (BI) Policy recognizing corruption as a security risk. Efforts to implement the BI policy in countries such as Ukraine are an integral part of the "Defence Institution and Capacity Building Directorate" in the Operations Division.

How would you describe the importance of building integrity for NATO today and the link with the Centre's editorial project Stabilization and Reconstruction in a Post-Conflict Environment, of which you are a co-editor?

Corruption risks are high in post-conflict situations. The publication under development will better prepare civilian and military staff to understand corruption risks, good practices to mitigate risks as well as detection and prosecution; ensuring taxpayers' resources are used for their intended purposes. This research and publication project is another example of the Centre's efforts to promote the transfer of knowledge and sharing of good practices. The publication includes a range of expert contributions addressing issues confronting those working in a post-conflict environment, human rights, impact of migration, and cooperation with other international organizations.

Speaker Spotlight: Francis Garon

Please tell us about your experience leading York University's internship program (or academic program) and the importance for a cooperation with International Organizations such as the NATO SFA COE.

The Master of Public and International Affairs at Glendon College, York University, is a two year, bilingual (French / English), and interdisciplinary program. The internship takes place in the summer between year one and year two, and it is one of the main features of the program. The agreement with the NATO SFA COE allows our students to experience working in an international organization dedicated to security issues. In fact, this agreement is the first that the program signed with an international organization, which makes it very special. Most of our students are interested in international affairs, broadly defined, which makes this agreement timely and highly relevant.

What advice do you have for students and young people hoping to join an internship?

My advice to the students who will be joining this internship would be to open their minds and take everything they can from the experience. Doing an internship means realizing a set of tasks, but it is also a human and cultural experience. It is where students begin to learn how organizations function and how to interact with others in different contexts. So I would tell them to invest themselves in their new environment and learn as much as they can on the issues, but also on the dynamics and practices that they will observe.

Is there anything else you would like to add?

As the Director of the program, I'm delighted that our students will have the opportunity to do their internship with the NATO SFA COE. The mandate and objectives of the organization fit perfectly with our program and the needs of our students.



On the 6th of July 2023, the NATO SFA COE held an Editorial Roundtable with authors of the upcoming book project, Stabilization and Reconstruction in а Post-Conflict Environment. The NATO SFA COE Director, Colonel Massimo Di Pietro, opened the session with an overview of why post-conflict reconstruction is particularly important in today's geopolitical context and where the Centre can help to convene scholarship that will aid SFA advisors for years to come. With the co-editors and associated editors of the book, Susan Pond (York University), Borja Montes Toscano (SHAPE) and Edoardo Gimigliano (IIHL), the importance of academic partnerships in advancing interdisciplinary research was underscored.

Professor Fabrizio Luciolli, President of the Italian Atlantic Committee and NATO SFA COE Senior Fellow, then delivered a strong address focused on the importance of SFA in dynamic and challenging contexts, emphasizing the need for interdisciplinary cooperation.

With authors representing a range of prestigious think tanks, institutes, universities, and multilateral bodies, including the NATO Mission Iraq (NMI), the Roundtable convened four panels according to the main preliminary themes of the paper, all related to the common topic of threats to human security: Gender, Culture and Institutions, Anti-Corruption and Transparency, and Protection of Civilians (POC). In the pages below, you can find an interview with an author of one of the chapters in the Gender section, Yael Vias Gvirsman, discussing her collaboration with the project and the importance of an intersectional lens on human security.







Participants in the Culture and Institutions panel discussed a range of topics from religion and cultural heritage to training and contracting, with a focus on what SFA Advisors can practically use in the field. The Anti-Corruption and Transparency panel defined these terms broadly, looking at all dimensions of citizen participation and accountability in key post-conflict decisions. Finally, the panel on POC considered various types of vulnerable groups, such as children, and a focus on all aspects of human security such as access to water and vital resources.

In line with the Centre's mission to support academic collaboration and foster emerging research in the field of SFA, the book project will also give an opportunity to highlight student research. Among our accepted authors are some students pursuing diverse degree programs in law, policy, economics and international relations at premier institutions around the world. As part of our cooperation with universities, the NATO SFA COE Interns also have the chance to contribute to the editorial process throughout the development of the topics and chapters.



Speaker Spotlight:Prof. Yael Vias Gvirsman

Founding Director of the International Criminal and Humanitarian Law Clinic at the Harry Radzyner Law School at Reichman University

Please talk to us about the project of the Law Clinic you are carrying out in collaboration with SHAPE. How is this project relevant for younger generations?

The International Criminal and Humanitarian Law Clinic was established in 2014 and in 2019 a Memorandum of Understanding (MOU) with the SHAPE Office of Legal Affairs (OLA) was signed. Since then, there has been a fruitful collaboration: research was carried out with law students to contribute in legal operations, based on top notch issues of international criminal law. This cooperation is fundamental for the younger generation of new lawyers and especially important for the context of the Clinic, an apolitical Clinic working in a conflict situation where it is increasingly important to provide students with the necessary experience to cope with the crisis environment.

Please tell us more about your chapter in the upcoming publication Stabilization and Reconstruction in a Post-Conflict Environment. What is the focus and how is it going to contribute to the aim of the book?

The topic of the chapter is women in international criminal law, agencies for stabilization and reconstruction. The main aim is to describe what used to be a blind spot of international criminal law: women as both victims of crimes and a solution for peace; and how this is now included in the international agenda. Focusing on the legal perspective and on the legal tools: how this is put into practice and how women are now pivotal for this outcome.

One piece of advice you would give to your younger self?

Be fearless, believe in yourself, you will look back 20 years from now and know it was all worth it.


